Introduction

1. The present Part of the report is submitted to Member States as requested by the Governing Council in the following decisions:
 - a) GC.24/9, paragraph 24, which “requests the Executive Director, further to article VI of the general procedures governing the operations of the Fund, to make available to Governments, twice a year, information on the progress made in the implementation of the programme of work and further requests that the information be structured in accordance with the programme of work”;
 - b) GC.24/9, paragraph 10, which “requests the Executive Director to continue the shift in emphasis from delivery of outputs to achievements of results, ensuring that United Nations Environment Programme managers at all levels take responsibility for the achievement of the programme objectives and the efficient and transparent utilization of resources to that end, subject to United Nations processes of review, evaluation and oversight”.
 - c) GC.SS.VI/2, paragraph 4, which “requests that future activity reports to the Governing Council and to the Committee of Permanent Representatives should present a clear correlation between relevant decisions of the Governing Council and other legislative bodies, activities and resources set aside, actual budget expenditure, and qualitative evaluation of results achieved”.
 - d) GC.24/1, paragraph 4, which “requests the Executive Director to present progress reports on the implementation of the Bali Strategic Plan on an annual basis to the Committee of Permanent Representatives, indicating clearly the ongoing activities and results, including the allocated budgets, that fall within the framework of the Bali Strategic Plan, as well as biannual summary of activities and results”.
2. The report provides information on the subprogramme progress in the implementation of the programme of work, as well as related financial performance. The report shows the progress in Bali Strategic Plan implementation by summarizing the capacity-building and technology support outputs of each subprogramme, as well as indicating detailed interventions in the regions.²

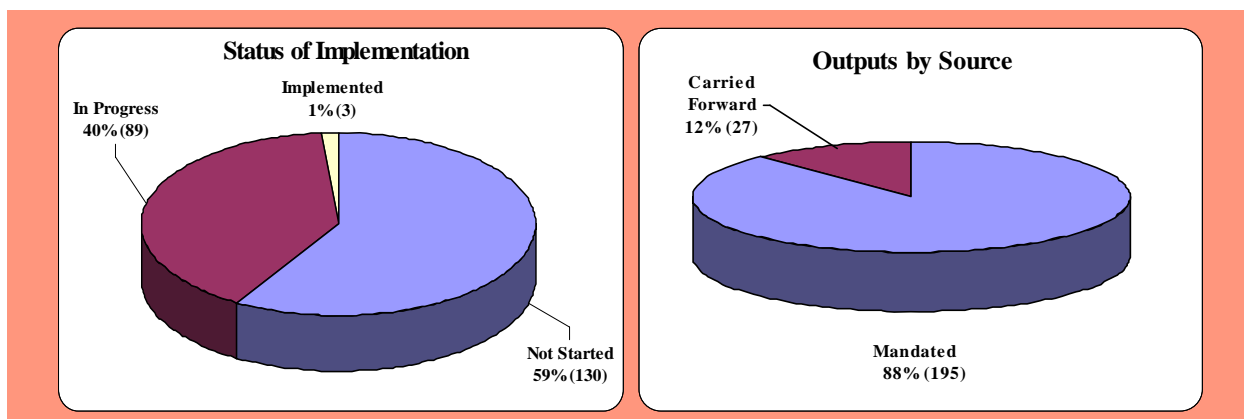

REVIEW OF WORK PROGRAMME IMPLEMENTATION AND THE RELATED FINANCIAL PERFORMANCE

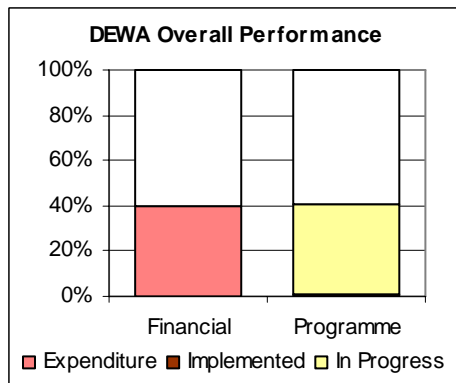
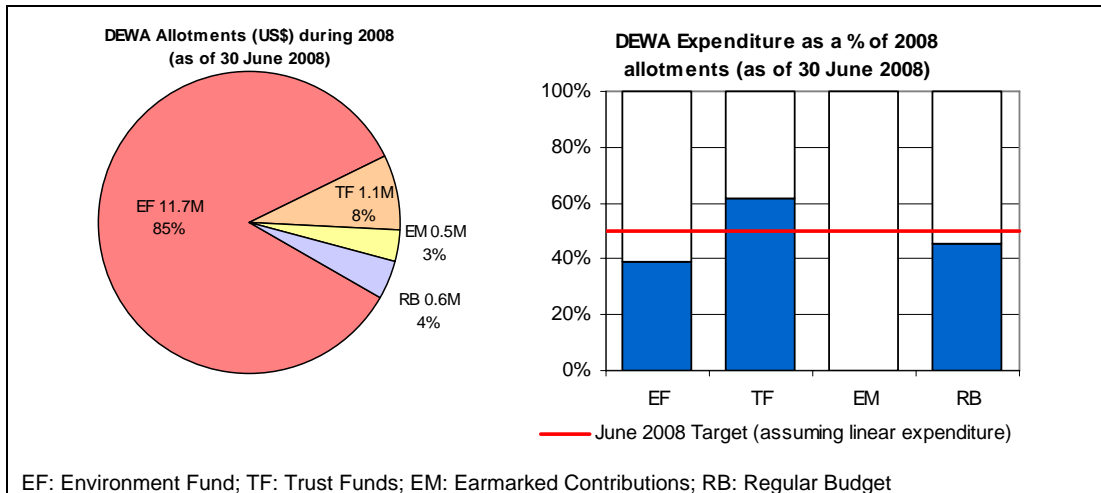
Upon finalizing the reporting for the 6-month review, the DEWA work programme delivery is progressing with 40 % of the mandated outputs currently under implementation, 1 % implemented and 59 % not started.



88 % of the final outputs are mandated in the programme budget for 2008-2009 and 12 % of outputs are carried forward³ from the 2006-2007 programme of work.

The related financial performance is as follows:

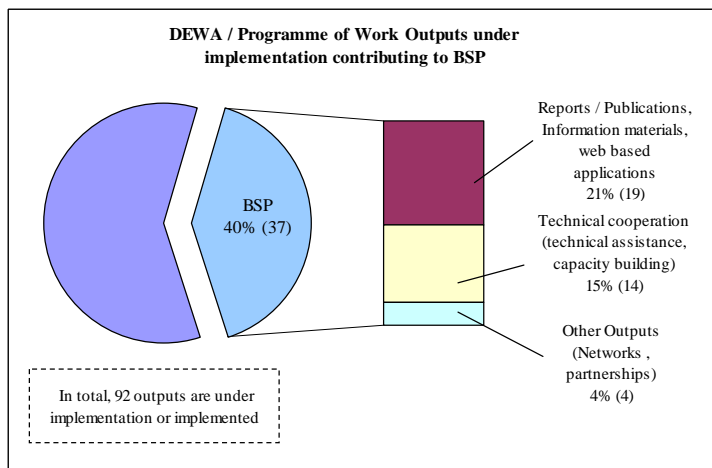


As of 30 June 2008, annual resources allotted for DEWA's programme amounted to US\$ 13.9 million of which 85% were from the Environment Fund, 8% from Trust Funds, 3% from Earmarked Contributions and 4% from the Regular Budget⁴.

Expenditure figures indicate that 0% of Earmarked contributions (3% of DEWA's total allotments) have been expended, however, as these resources are being implemented in collaboration with partners, they are only reflected in UNEP's accounts when financial reports are received from partners.

Overall, both financial and programme implementation are progressing at equivalent rates of approximately 40%.

Progress in the implementation of Bali Strategic Plan



Out of the total of 92 outputs which are currently under implementation, 37 (40%) are contributing to the Bali Strategic Plan (BSP) implementation. Most of the BSP assigned outputs are reports, publications, information materials, e-learning tools and web based applications (21%), as well as capacity building and technical assistance services (15%).

The details of the BSP relevant outputs by regions are provided in Annex 1.

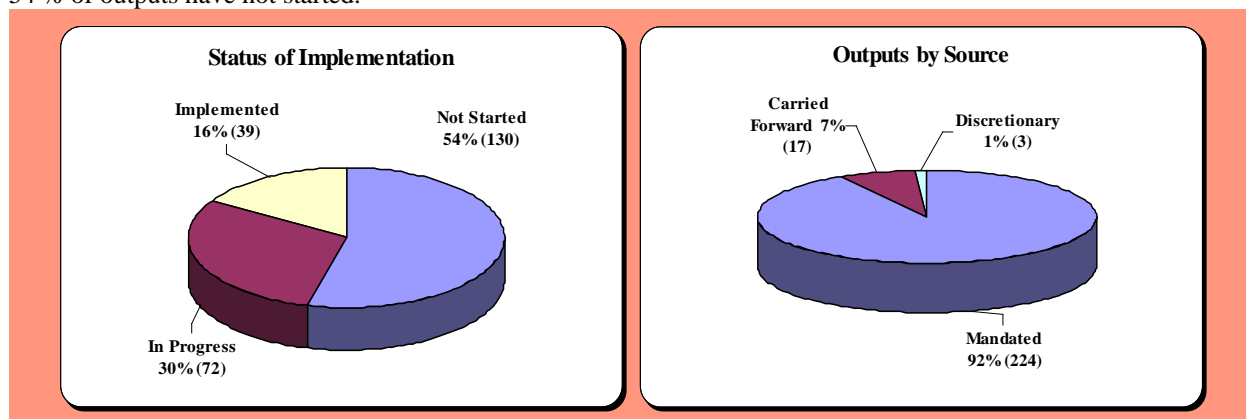

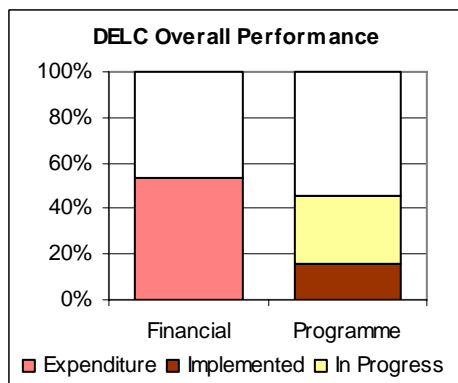
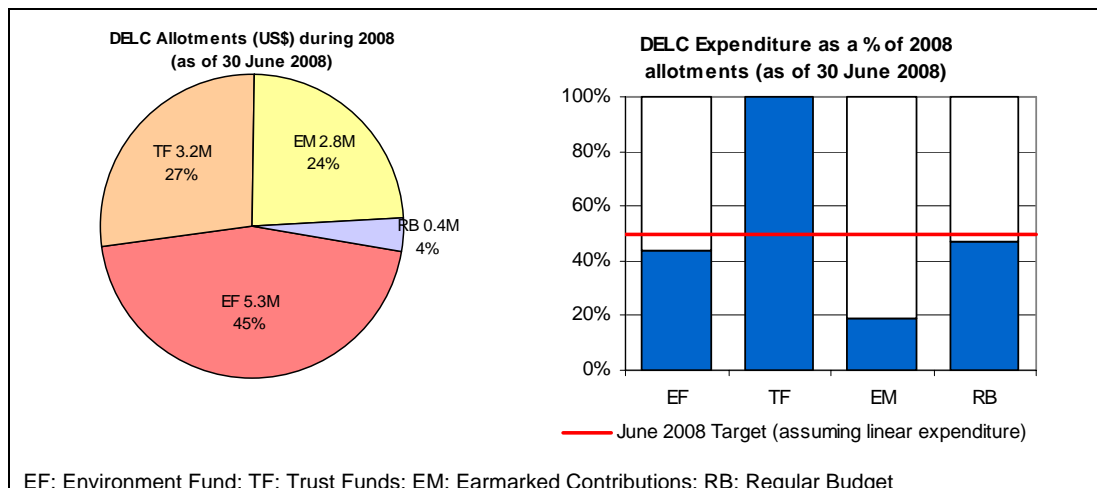
REVIEW OF WORK PROGRAMME IMPLEMENTATION AND THE RELATED FINANCIAL PERFORMANCE

Upon finalizing the reporting for the 6-month review, the DELC work programme delivery is progressing with almost half of the mandated outputs implemented (16 %) or currently under implementation (30 %). 54 % of outputs have not started.



92 % of the final outputs are mandated in the programme budget for 2008-2009 and 7 % of outputs are carried forward⁵ from the 2006-2007 programme of work. 1 % of the outputs are introduced by the discretion of the programme managers.

The related financial performance is as follows:



As of 30 June 2008, annual resources allotted for DELC's programme amounted to US\$ 11.7 million with 45% from the Environment Fund, 27% from Trust Funds, 24% from Earmarked Contributions and 4% from the Regular Budget⁶.

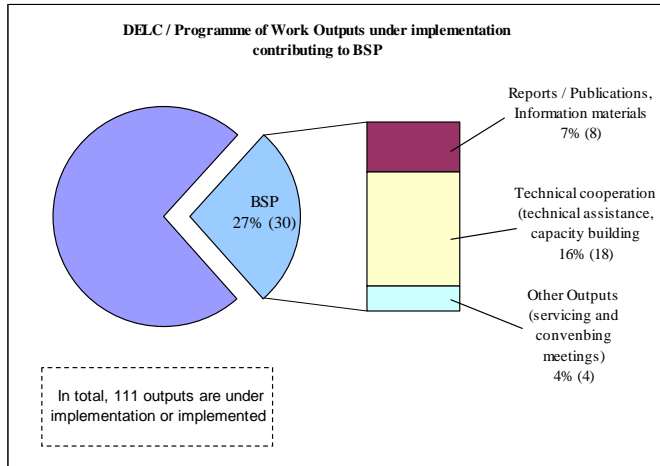
DELC's expenditure shows that Trust Funds were fully expended, however as these resources are only allotted when contributions are received, the proportions of allotment to expenditure are likely to change as more Trust Fund resources are received. In addition, the 20% expenditure on Earmarked Contributions does not account for expenditures that are implemented in collaboration with partners until financial reports from implementing partners are received.

Overall, DELC's financial and programme performances are progressing at equivalent rates of 50%.

Out of the total of 111 outputs which are currently under implementation, 30 (27 %) outputs are contributing to the Bali Strategic Plan (BSP) implementation. Over half of the BSP assigned outputs are capacity building and technical assistance services (16 %). Others include reports, publications, information materials (7 %) and servicing and convening of meetings (4 %).

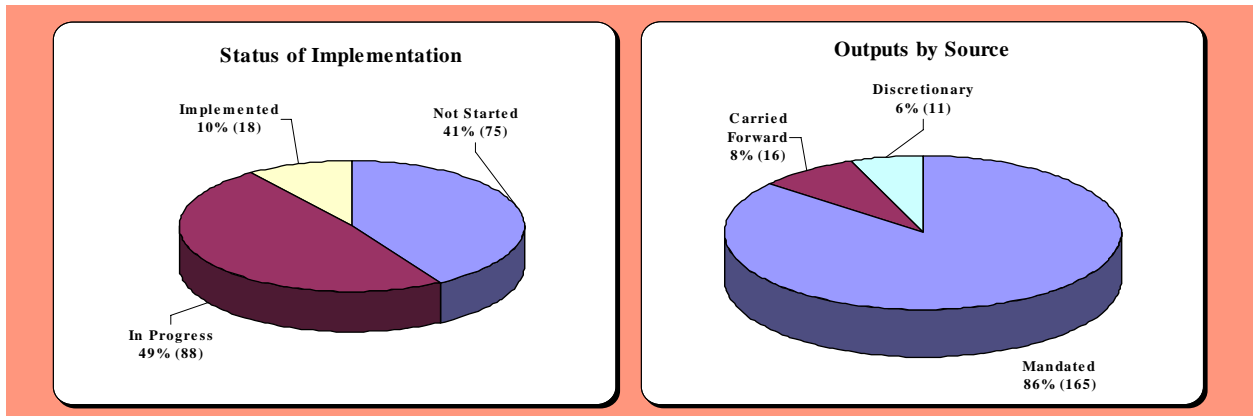

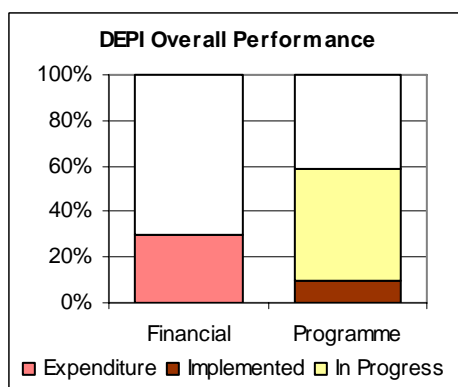
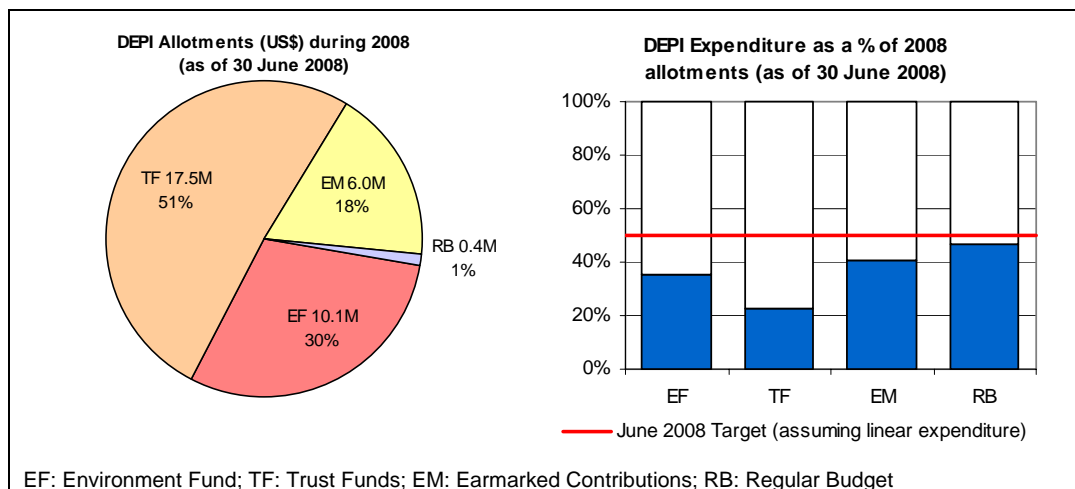
REVIEW ON WORK PROGRAMME IMPLEMENTATION AND THE RELATED FINANCIAL PERFORMANCE

Upon finalizing the reporting for the 6-month review, the DEPI work programme delivery is progressing with over half of the mandated outputs implemented (10 %) or currently under implementation (49 %). 41 % of outputs have not started.



86 % of the final outputs are mandated in the programme budget for 2008-2009 and 8 % of outputs are carried forward⁷ from the 2006-2007 programme of work. 6 % of the outputs are introduced by the discretion of the programme managers.

The related financial performance is as follows:



As of 30 June 2008, annual resources allotted for DEPI’s programme amounted to US\$ 34 million with 30% from the Environment Fund, 51% from Trust Funds, 18% from Earmarked Contributions and 1% from the Regular Budget⁸.

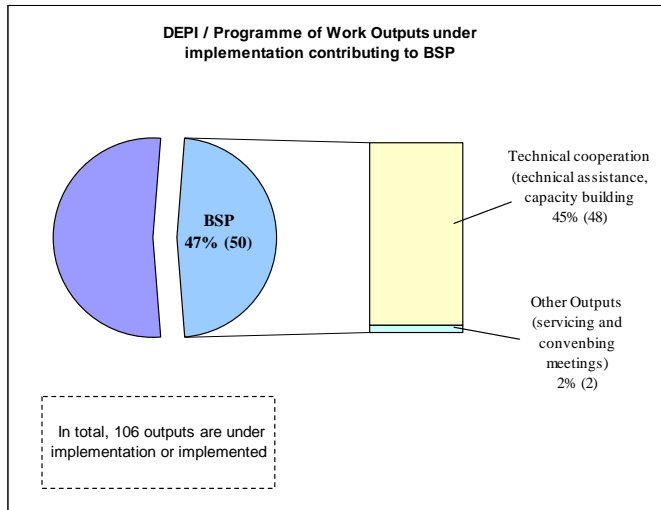
DEPI’s expenditure shows that Trust Fund expenditure stands at 23%, however, it is worth noting that allotment of Trust Fund resources are only effected when received and hence a lag in the receipt of such resources delays their programming and expenditure.

Overall, DEPI’s programme implementation progress of approximately 60% exceeds financial performance which stands at approximately 30%.

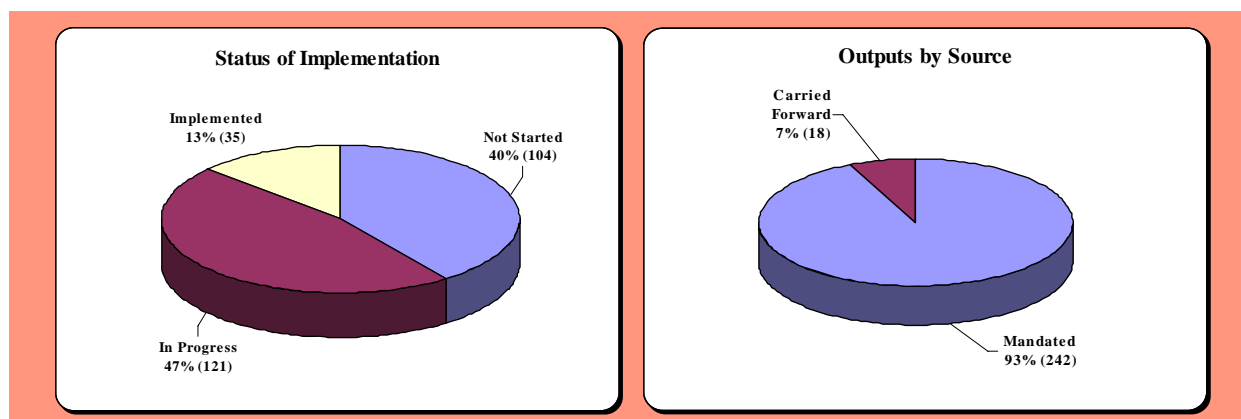

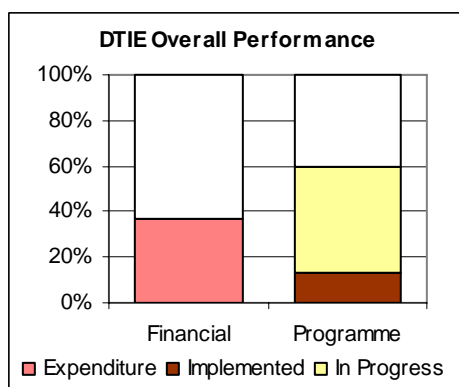
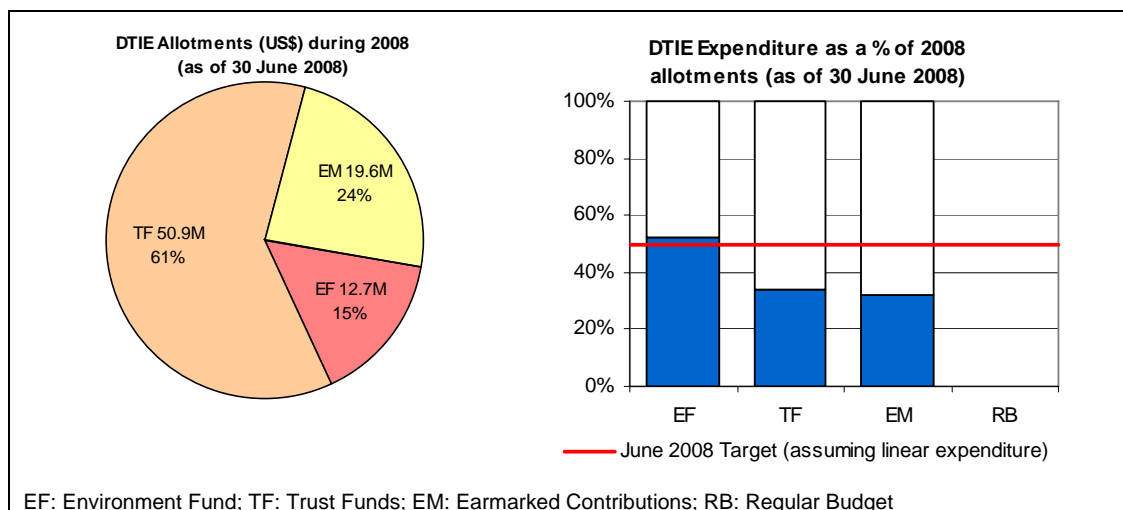

Upon finalizing the reporting for the 6-month review, the DTIE work programme delivery is progressing with over half of the mandated outputs implemented (13 %) or currently under implementation (47 %). 40 % of outputs have not started.



93 % of the final outputs are mandated in the programme budget for 2008-2009 and 7 % of outputs are carried forward⁹ from the 2006-2007 programme of work.

The related financial performance is as follows:



As of 30 June 2008, annual resources allotted for DTIE’s programme amounted to US\$ 83.2 million with 15% from the Environment Fund, 61% from Trust Funds and 24% from Earmarked Contributions¹⁰.

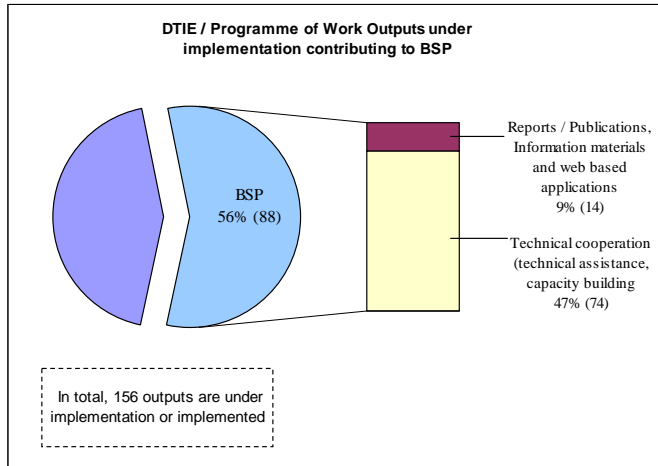
DTIE’s use of Trust Funds and Earmarked Contributions stand at 34% and 32% respectively, both reasonable levels of expenditure at this stage in the year considering that these funds are only allotted when contributions are received and activities implemented in collaboration with partner institutions are only recorded in UNEP accounts when expenditure reports are received from implementing partners.

Overall, programme implementation progress of approximately 60% exceeds financial performance which stands at 36%.

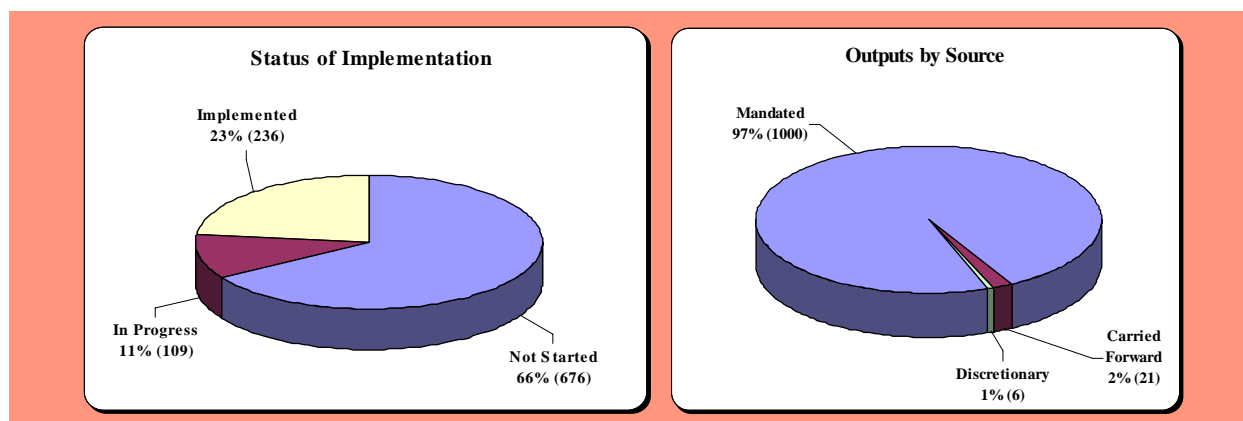

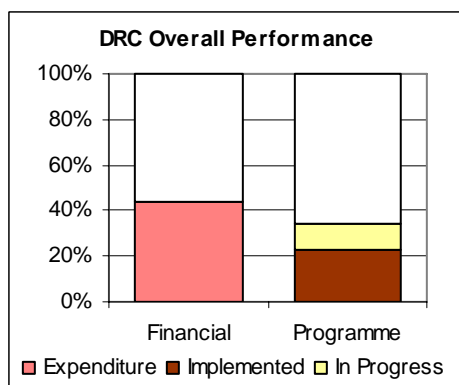
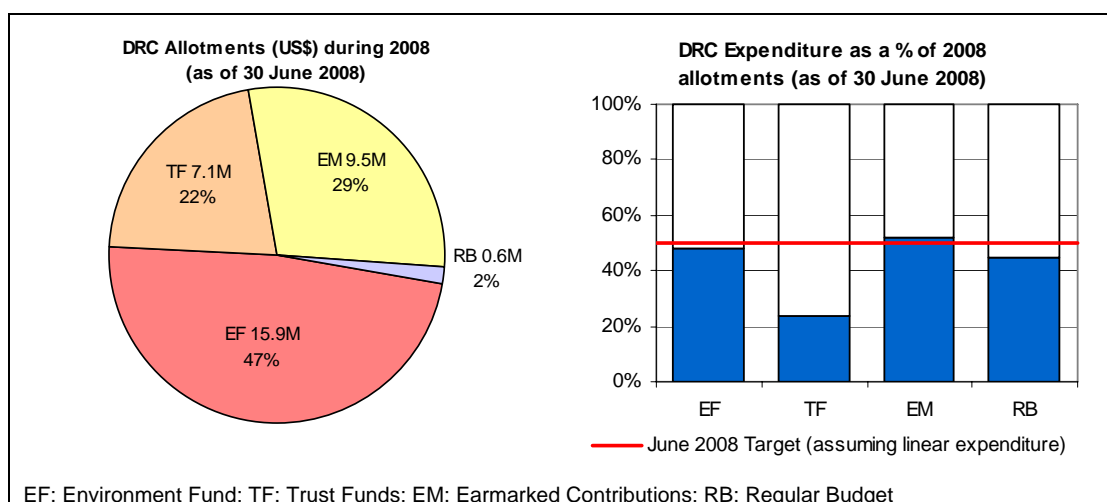
REVIEW ON WORK PROGRAMME IMPLEMENTATION AND THE RELATED FINANCIAL PERFORMANCE

Upon finalizing the reporting for the 6-month review, the DRC work programme delivery is progressing with almost a third of outputs implemented (23 %) or currently under implementation (11 %). 66 % of outputs have not started.



97 % of the final outputs are mandated in the programme budget for 2008-2009 and 2 % of outputs are carried forward¹¹ from the 2006-2007 programme of work. 1 % of the outputs are introduced by the discretion of the programme managers.

The related financial performance is as follows:



As of 30 June 2008, annual resources allotted for DRC's programme amounted to US\$ 33 million with 47% from the Environment Fund, 22% from Trust Funds, 29% from Earmarked Contributions and 2% from the Regular Budget¹².

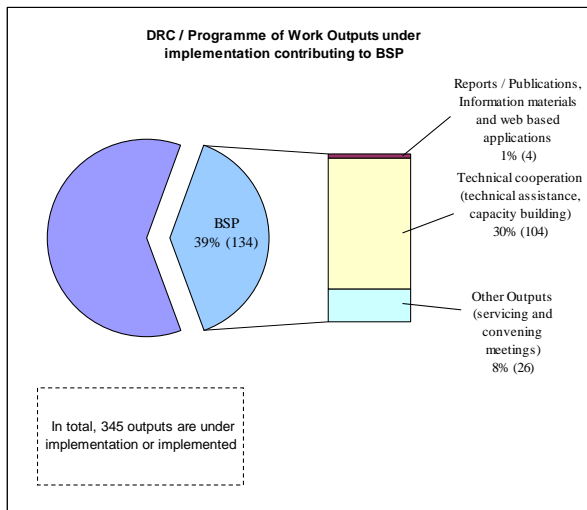
The use of Trust Funds stands at 23%, however, it is worth noting that allotment of Trust Fund resources are only effected when received and hence a lag in the receipt of such resources delays their programming and expenditure.

Overall, programme implementation progress stands at 34%, slightly below financial performance which stands at 44%.

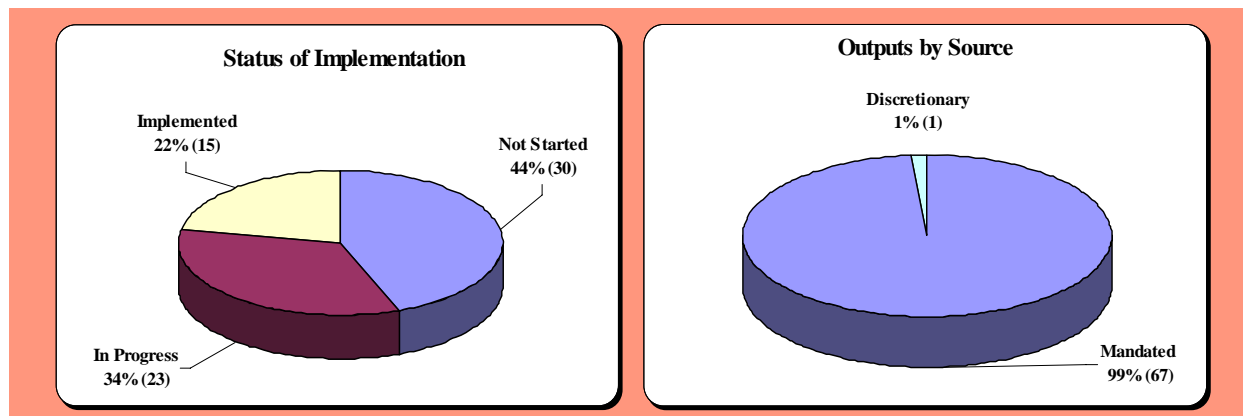

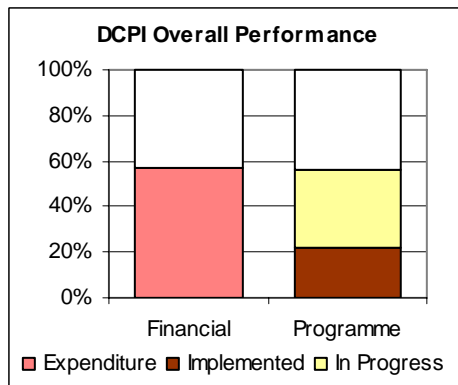
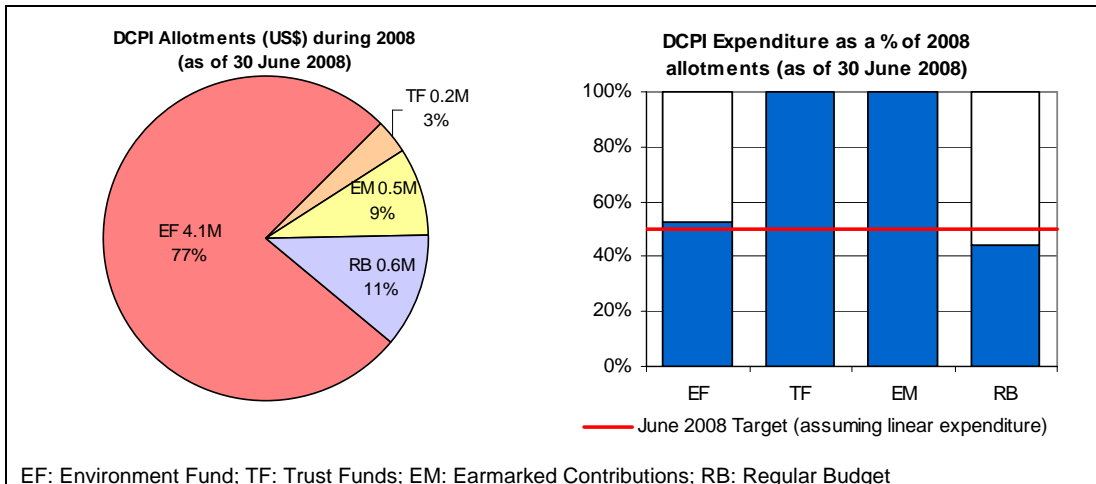

Upon finalizing the reporting for the 6-month review, the DCPI work programme delivery is progressing with over half of outputs either implemented (22 %) or currently under implementation (34 %). 44 % of outputs have not started.



99 % of the final outputs are mandated in the programme budget for 2008-2009 and 1 % of the outputs are introduced by the discretion of the programme managers.

The related financial performance is as follows:

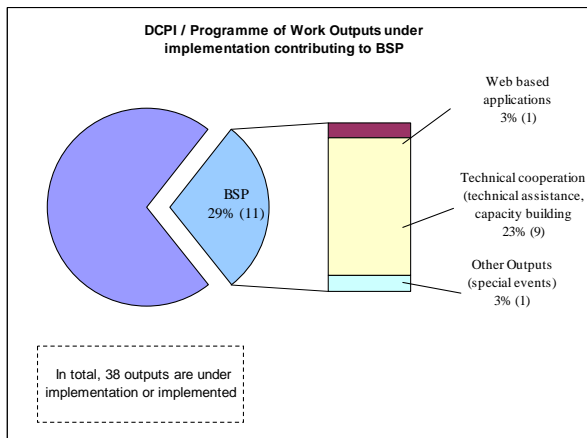


As of 30 June 2008, annual resources allotted for DCPI's programme amounted to US\$ 5.4 million with 77% from the Environment Fund, 3% from Trust Funds, 9% from Earmarked Contributions and 11% from the Regular Budget¹³.

Although Trust Funds and Earmarked Contributions comprise 11% of DCPI's overall allotments, these resources have been fully utilized. However, the proportion of allotted to unexpended resources under these categories of funding are likely to change as the biennium progresses, particularly as the allotment of Trust Funds and Earmarked Contributions are only effected when contributions are received.

Overall, DCPI's financial and programme performances are progressing at equivalent rates of approximately 60%.

Progress in the implementation of Bali Strategic Plan



Out of the total of 38 outputs which are currently under implementation, 11 (29 %) outputs are contributing to the Bali Strategic Plan (BSP) implementation. Almost all of the BSP assigned outputs are capacity building and technical assistance services (23 %).

The details of the BSP relevant outputs by regions are provided in Annex 1.
